# November 4 | 8am-10:30am

Painting 101

This course covers the basics of designing a well-planned kitchen and how to install cabinetry, including the design process, material choices for cabinets and counters, utility and appliance placement, traffic flow and storage.

2024 IECC HVAC, Plumbing & Lighting.

2 ½ credit hours - taught by Larry Desormier (IN-PERSON)
This module covers the code requirements for HVAC systems, service water heating, and lighting for the 2024 IECC along with installation best practices. Module will dive into how R408 compliments the mandatory requirements of the prescriptive pathway.

2024 Modeled Pathways Module

2 1/2 credit hours - taught by Larry Desormier (IN-PERSON) This module covers compliance with the 2024 IECC throug the two modeled compliance pathways. R405 Simulated Building Performance and R406 Energy Rating Index. Key learning objectives include the differences between the compliance pathways, the process for energy modeling and potential tradeoffs. Modeled examples in Climate Zone 5 will be presented.
